

****Acker Night Holiday Sweepstakes Rules****

1. ****Eligibility****

3. ****Agreement to Official Rules****

- The Sweepstakes begins on December 06, 2023 at 12:01am MST and ends on December 10, 2023 at 11:59pm MST (the "Sweepstakes Period"). Entries submitted before or after the Sweepstakes Period will be disqualified. Limit of one entry per email address.
- Submissions will be accepted for the duration of the Sweepstakes.

5. ****How to Enter****

- There is a limit of one (1) entry per person, per email address for the duration of the Sweepstakes Period, regardless of the method of entry. Entries exceeding this limit will be void.

6. ****Winner Selection****

- On or about December 15, 2023, the Sponsor will select potential winners in a random drawing from all eligible entries received. The odds of being selected depend on the number of entries.
- The Sponsor will attempt to notify the potential winner via telephone or email on or about December 15, 2023. If the potential winner cannot be contacted within five (5) days after the first attempt, the Sponsor may select an alternate winner.

7. ****Winner Requirements****

- The potential winner will be required to complete, electronically sign, and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, to claim their prize.
- If a potential winner cannot be contacted, fails to submit the Declaration of Compliance within the required time period, or the prize is returned as undeliverable, they forfeit the prize.
- If the potential winner is a minor in their jurisdiction of residence, the Sponsor may award the prize in the name of the winner's parent or legal guardian.
- In the event of disqualification, the Sponsor will award the prize to an alternate winner by random drawing. Only three (2) alternate drawings will be held, after which the prize will remain unawarded.
