

Tracy Lawrence Dad's Night Out Sweepstakes

1. **Eligibility** The Tracy Lawrence Dad's Night Out Sweepstakes (the "Sweepstakes") is open to US residents who are at least eighteen (18) years old at the time of entry. Entries submitted before or after the Sweepstakes Period will be disqualified. Limit of one entry per email address. Submissions will be accepted for the duration of the Sweepstakes.

6. **Winner Selection** On or about June 29, 2026, the Sponsor will select the potential winner in a random drawing from all eligible entries received. The odds of being selected depend on the number of entries. The Sponsor will attempt to notify the potential winner via email and telephone. If the potential winner cannot be contacted using the email or telephone number provided within two (2) business days after the first attempt, the Sponsor may select an alternate winner.
7. **Winner Requirements** The potential winner will be required to complete, sign, and submit a Declaration of Compliance within two (2) business days of the first attempted notice to claim their prize. The winner must provide proof of age to claim prizes. If a potential winner cannot be contacted, fails to submit the Declaration of Compliance within the required time period, or the prize communication is returned as undeliverable, they forfeit the prize.
